

## STREET TRADING INFORMATION

**Sites situated at The Quay, Harwich, Barrack Lane, Harwich, The Walls, Mistley.**

Before you are able to start trading at any of the above sites you are required to do the following:-

Check with the Licensing Office at Tendring District Council that the site you are interested in is available.

If the site is free you will need to complete the enclosed Street Trading Consent Form and return with the fee of £530.00 together with 1 passport sized photograph of all employees and return this to The Licensing Manager, 88-90 Pier Avenue, Clacton on Sea, Essex CO15 1TN

You will also need to apply to Environmental Services at Tendring District Council to register the vehicle to sell food/drink and to obtain a Health and Hygiene Permit. This will need to be done 28 days before the date you wish to commence trading.

Please be aware that the Licensing Office is only open for personal callers Tuesdays and Wednesdays between the hours of 10.00 a.m. and 12.00 midday and Friday between the hours of 1.00 p.m. and 4.00 p.m. outside of these times an appointment will need to be made with a member of the Licensing Team.
