This Order prohibits you from doing the acts set out in this Order. If you disobey this Order you may be found guilty of Contempt of Court and may be sent to prison or fined or your assets may be seized.

UPON hearing Counsel for the Claimants without notice to the Defendants

AND UPON The First Claimant undertaking to serve this Order as directed by paragraph 3 of this Order as soon as possible

AND UPON on the Claimants' application for an injunction in relation to the land at The Naze at Walton-on-the-Naze, Essex as shown edged red on the plan attached to this Order ("the Land"),

IT IS ORDERED that:

- 1. The Defendants and each of them shall not:
 - (a) Leave or permit to remain any campervan, mobile home or caravan or tent on the Land;
- This Order shall have effect from 00:01 hours on 1st October 2014 until 23:59 on 31st October 2016.

FURTHER ORDERS

- 3. The Court ordered under CPR Part 6.27 that service of this Order be effected by
 - (a) publishing a notice on the First Claimant's website alerting readers' attention to the terms of the Order and displaying a copy of this Order together with the attached plan;
 - (b) placing copies of this Order in clear plastic envelopes clearly marked, and secured to the land in a conspicuous position as set out below with

readers' attention being directed to the notice available on the First Claimant's website in accordance with paragraph 3(a) above :

- (i) in two separate positions at the entrance to the Land;
- (ii) on the external wall of the Council-owned kiosk on the Land;
- (iii) on the external wall of the public toilets on the Land; and
- (iv) on the main door of the Naze Tower.

and that personal service be dispensed with.

- 4. The Court further ordered under CPR Part 6.15 that service of the Claim Form be effected by leaving sufficient copies available for collection on request during office hours at the Town Hall, Station Road, Clacton on Sea, Essex, CO15 1SE, and at the Council Offices in Weeley and publishing a notice on the First Claimant's website advertising the availability of such copies and that the Claim Form be deemed served 7 days after the date of this Order, and that the period for filing an admission, defence or acknowledgement of service be 21 days after the date of this Order.
- 5. The Court further ordered that any person may apply to the Court on notice to the Claimants to ask the Court to set aside or vary the Order. For the avoidance of doubt such an application shall not by itself affect the requirement to obey this order at any time before the Court has considered the application and decided to vary the Order. 
Parties other than the Claimant and Defendant

Interpretation of this Order

- C. In this Order, where there is more than one Defendant, (unless otherwise stated) references to "the Defendant" means both or all of them.
- (1) A requirement to serve on "the Defendant" means on each of them. However, the Order is effective against any Defendant on whom it is served.
- (2) An Order requiring "the Defendant" to do or not to do anything applies to all Defendants.
