

78. HERITAGE ECONOMIC REGENERATION SCHEME: POSSIBLE BID
WALTON-ON-THE-NAZE

The Committee gave consideration to a detailed report which advised them of the process for the Heritage Economic Regeneration Scheme (HERS) rounds 3 and identified the focus for a possible bid. The report also sought Members' views on possible submission of a HERS bid for Walton-on-the-Naze and considered whether a bid could be financially supported in relation to the Council's Financial Action Plan and other corporate priorities.

It was moved by Councillor King, seconded by Councillor Johnson and:-

RESOLVED – (a) That in the absence of budgetary provision being available at this time for such a project in 2001/2002 the Council does not support a Heritage Economic Regeneration Scheme round 3 bid for Walton-on-the-Naze.

(b) That, as a result of the expiry of the Harwich Heritage Economic Regeneration Scheme at the end of 2001/2002, £20,000 per annum be allocated in the five-year financial forecast for a period of three years towards making a Heritage Economic Regeneration Scheme round 4 bid for Walton-on-the-Naze, particularly in the light of the related Mersey Towns Initiative bid for Walton-on-the-Naze.

79. ESSEX VEHICLE PARKING STANDARDS: CONSULTATION DRAFT

Further to Minute 61 (24.1.01) Members were advised of the response of the consultation process on the Essex Planning Officers Association (EPOA) document "Vehicle Parking Standards: Consultation Draft" and their approval was sought from the Council's response to the EPOA on such document.

It was moved by Councillor De-Vaux Balbirnie, seconded by Councillor White and:-

RESOLVED – (a) That the comments received as a result of the local consultation exercise be noted and that the submissions received be forwarded to the Essex Planning Officers Association.

(b) That the Council's response to "Vehicle Parking Standards: Consultation Draft" set out in Section 4.0 (i)-(v) of item A.2 of the Report of the Acting Head of Planning and Building Services be approved and be forwarded to the Essex Planning Officers Association by 1 April 2001.

80. DRAFT SUPPLEMENTARY PLANNING GUIDANCE ON CRIME REDUCTION
THROUGH ENVIRONMENTAL DESIGN: RESULTS OF CONSULTATION

Further to Minute 50 (22.11.00) Members were advised of the comments arising from the consultation exercise on the proposed Crime Reduction through Environmental Design Supplementary Planning Guidance and their approval was sought for amendments to the guidance in the light of the comments received and for the formal adoption of the amended guidance as Supplementary Planning Guidance.

It was moved by Councillor Harper, seconded by Councillor White and:-

RESOLVED – (a) That the revised guidance on Crime Reduction Through Environmental Design, as set out as Appendix 'B' to item A.3 of the Report of the Acting Head of Planning and Building Services be approved and be adopted as Supplementary Planning Guidance.

(b) That copies of such guidance be sent to all consultees and be made available free of charge to applicants for planning permission at the offices of the Council's Planning and Building Service.

81. TENDRING DISTRICT REVIEW LOCAL PLAN: REVISED INDICATIVE TIMETABLE

The Committee gave consideration to a revised indicative timetable for the Local Plan Review.

The Committee formally considered the report in conjunction with the recommendations contained in Minute 11 of the Local Plans Panel meeting of 31 January 2001.

It was moved by Councillor Harper, seconded by Councillor De-Vaux Balbirnie and:-

RESOLVED – (a) That the revised indicative timetable for the Tendring District Review Local Plan, as set out as Appendix 'B' to item A.4 of the Report of the Acting Head of Planning and Building Services, be approved.

(b) That the revised indicative timetable be published and that the Government Office for the Eastern Region and Essex County Council be advised accordingly and that any comments received from those two bodies be reported to a future meeting of the Committee.

(c) That the suggested prioritisation of other discretionary work be endorsed.

(d) That this Committee make further representations to the Resources Management Committee to fill the existing vacancy in the Policy and Conservation section as soon as possible.

83. DIVERSION OF PART OF FOOTPATH 27, ARDLEIGH

The Committee gave consideration to a report which sought their authorisation for the diversion of part of Footpath 27 at the rear of Chapel Croft, Ardleigh.

It was moved by Councillor De-Vaux Balbirnie, seconded by Councillor Johnson and:-

RESOLVED – (a) That the Head of Legal and Administration Services be authorised to make a Footpath Diversion Order under Section 119 of the Highways Act 1980, as shown on Drawing No. E/H/4391 and to give all necessary public notices in accordance with Schedule 6 to the said Act in relation to such Order.
